3. GREATER VICTORIA POLICE DIVERSITY ADVISORY COMMITTEE (GVPDAC)

The Board was invited to participate in the virtual GVPDAC meeting on July 8 at 1700 hours. The GVPDAC representatives and Dr. Gunderson remained at the meeting for the purpose of the meeting between representatives of the Black Community and the Board.
